Definition of types of stockbroker:

- Online:** Online share dealing service where shares are bought and sold on your behalf and no advice is offered.
- Execution-only:** Share dealing service where shares are bought and sold on your behalf and no advice is offered.
- Advisory:** Same as execution-only but with additional investment advice on request, although the final decisions are left up to you.
- Discretionary:** The service includes complete management of your investments, including authority to buy and sell on your behalf.
