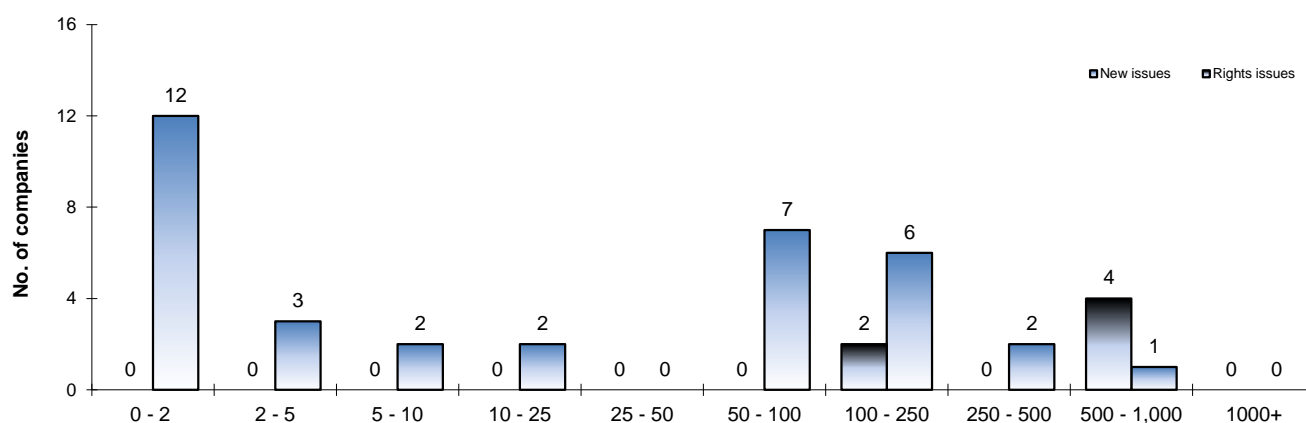

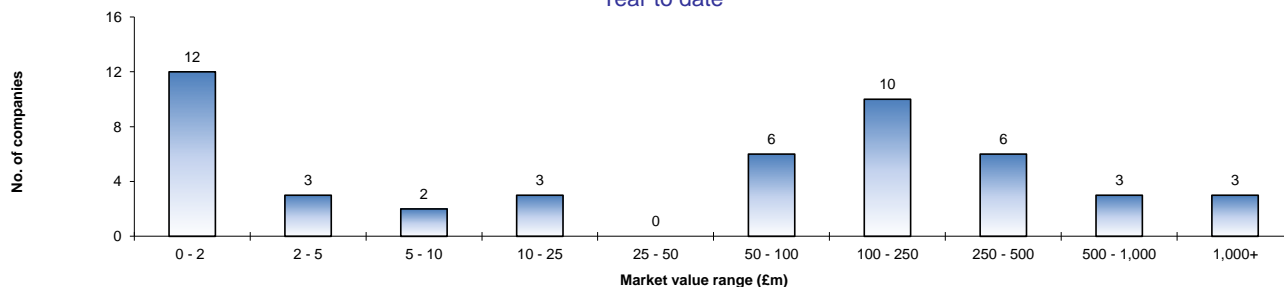

Year to date



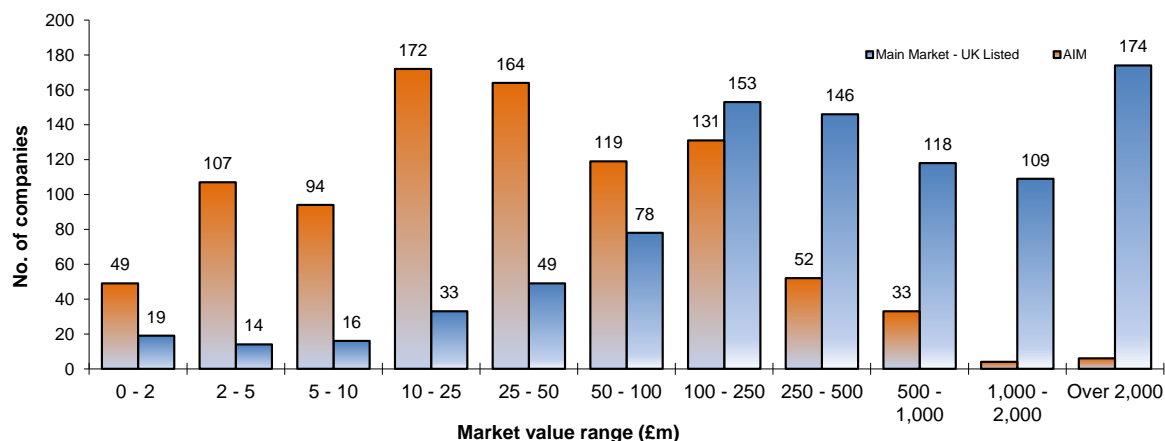
